## Task #1: Review of the Public Comments for the Recommendations

## **Review Process:**

Tara constructed and presented a table containing columns for the public comments. The three columns are: Topic, Question/Comment and Suggested Response. Our process was to have a discussion on each comment and craft a response for each comment; some of the responses were used for multiple comments that had similar themes. The final response selection was decided by group consensus. The process resulted in completion of the responses for all but six which will require more work including possible changes in the text of the Recommendations.

- 1. The word "uninterested" (p. 2) will be removed from the definition for Peer Policy Coalition.
  - Task completed--
- 2. The Oversight Board members' selection (p. 5) requires that we create **a rubric** for the initial Oversight Board and include it in the Recommendations.
  - More work is needed--
- 3. In section on Board member selection (p.6, sec. 5. i. iv.) the disqualification from the Ethics Committee for personal non-professional relationships with individuals connected to the Certifying Organization or the NCDHHS may be too broad. The Commission will revisit the exclusionary criteria for the Ethics Committee membership.
  - More work is needed in narrowing the scope of disqualifying factors/conflicts—
- 4. The Ethics Committee member selection requires (?)that we create a rubric for membership.
  - More work is needed-
- 5. The Expert Commission agreed to remove the words "certified mail" from (p.10, sec. 6.d. ii.) and (p.11, sec. 9.b.)

- 6. An additional task is to add language that states the board has the ability to make and amend rules.
